MoU between MSEC and SKC Chemicals




1. Purpose

The co-operation between MSEC and SKC Chemicals will facilitate effective utilization of the intellectual capabilities of the Conserve providing significant inputs to them in developing suitable teaching/ trainingsystems, keeping in mind the needs of MSEC.

2. Scope

- Both parties believe that close co-operation between the two would be a major benefit to the student community of **Chemical Engineering, Civil Engineering and Agricultural Engineering** to enhance their skills and knowledge.
- The SKC Chemicals will give valuable inputs to the MSEC in teaching/training methodology so that the students, fit into the industrial scenario meaningfully.
- The interaction between SKC Chemicals and MSEC will give an insight into the latest developments /requirements of the industries; the SKC Chemicals involves students of the MSEC to involve in Placement Training Programs, Project assistance, Internship and In-plant Training.

- The SKC Chemicals will train the students of the MSEC on Industrial, water treatment chemicals, maintenance of cooling towers, boilers in order to bridge the gap in skill and make them ready for industry.

3. Costs

The expenses for Training, Consumables, Certification, Travelling and Accommodation of the resource person will be payable by the beneficiaries (Students or MSEC). Certificates will be provided only for the students who have paid fully, the costs of the programs will be determined by separate quotations on case-by-case basis.

4. General Provisions

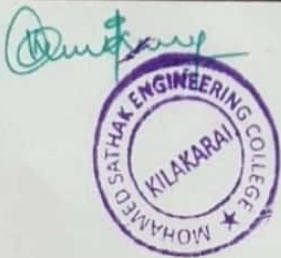
Treatment of intellectual property rights developed through collaborations under this MoU will be determined between the Parties through mutual consultation and separate written agreements on a case-by-case basis.

5. Confidentiality

The parties agree that there is no intention to share any confidential or proprietary information obtained in any collaboration under this MoU. If either Party wishes to disclose information it considers to be confidential or proprietary to the other Party, the Parties will enter into a written non-disclosure agreement.

6. Duration of MoU

This MoU may be modified or extended by mutual written agreement by the Parties. This MoU shall become effective upon signature by the authorized officials from the parties and will remain in effect until modified or terminated by any one of the partners by mutual consent. This MoU may be terminated by either party upon THREE (3) months advance written notice. MSEC and SKC Chemicals mutually agree to the terms and responsibilities of MoU for 5 years, duly signed from 24th February 2024 to 24th February 2029.
